Dear Mr. King:

dishNET Wireline L.L.C. (“dishNET”) provides courtesy notification of its compliance with the Federal Communications Commission’s (“FCC”) *Report and Order and Further Notice of Proposed Rulemaking* in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 11-161,¹ *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 12-47,² and Section 51.911 of the FCC’s rules, 47 C.F.R. §51.911, effective July 1, 2014.

dishNET is reducing its terminating intrastate end office rate elements by a third of the difference between its current end office rate elements and \$0.0007 applicable to price cap incumbent local exchange carriers per Section 51.907 of the FCC’s rules, 47 C.F.R. § 51.907, by adopting the corresponding terminating interstate switched access rates contained in its Tariff F.C.C. No. 1 for Washington. Further, dishNET reduces its intrastate toll VoIP-PSTN traffic rates by adopting the corresponding interstate access rates contained in its Tariff F.C.C. No. 1.
