This filing is made in in accordance with RCW 80.28.060, WAC 480-80-101 and -105, and WAC 480-07-880; and in compliance with Washington Utilities and Transportation Commission (Commission) Order 05 in consolidated dockets UG-200994, UG-200995, UG-200996, and UG-210085 issued October 21, 2021 (Order 05).<sup>1</sup>

## **Purpose**

The purpose of this filing is to provide the applicable tariff sheets listed in the table above in compliance with Order 05 and to reflect the combined effects of the Company's general rate revision approved in Order 05 and the effect of rate changes filed with the Commission as part of the Company's annual Purchased Gas Adjustment (PGA) and related filings effective on November 1, 2021, listed by docket above. The combined effect of these rate changes on customer bills is shown in the table below:

### **Background**

On December 18, 2020, NW Natural filed a general rate case docketed as UG-200994. In Order 05, the Commission approved the Multi-Party Settlement Agreement filed in UG-200994, resolving all issues in the case. The effective date of the Year One rates approved in Order 05 is November 1, 2021, and the effective date of the Year Two rates approved in Order 05 is November 1, 2022.<sup>2</sup>

On September 13, 2021, NW Natural filed its annual PGA and related filings in the dockets listed in the subject line of this compliance letter. The Commission will consider all of these filings at its October 28 open meeting, with an effective date of November 1, 2021.

## **Proposed Changes**

#### **UG-200994 Tariff Revisions**

The enclosed rate schedules reflect the changes adopted by Order 05 and are listed in the table of tariff sheet revisions above.

### Schedule 215 Adjustment to Rates for Energy Efficiency Service and Programs

In this compliance filing, the Company is updating the enclosed Schedule 215 to: 1) suspend half the Historical Balance amortization in the tariff by reducing the rates, effectively suspending half of the original amount; and, 2) add rates for the amortization of the Conservation Potential Assessment deferral.<sup>3</sup> The enclosed Schedule 215 reflects the same current year, or forecasted, costs (see column "Schedule G Current Year Costs" in tariff table in Schedule 215) that were filed in UG-210698 on September 13, 2021, which is scheduled to be considered at the October 28 open meeting. UG-210698 included the Twenty-Second Revision of Sheet 215.1. In this compliance filing, the Company is providing the Twenty-Third Revision of Sheet 215.1 and Original Sheet 215.2 to reflect the results of combining the rates contemplated in UG-210698 and Order 05.
