Notice of requested changes to PSE rates and public hearing

On December 9, 2020, we filed a power cost only rate case with the Washington Utilities and Transportation Commission (UTC) requesting an adjustment to electric rates. A power cost only rate case adjusts the costs from the purchase and generation of electricity that are included in electric rates.

We have requested the following

PSE's filing, if approved by the UTC, requests an increase of \$78.5 million in revenue and 3.67 percent in rates. Residential customers would see an overall average increase of 3.49 percent. A residential customer using 900 kWh per month would see a bill increase of \$3.42. All electric customers, except for retail wheeling and special contract customers, are affected by the change.

Reasons for requested rate increase

- Higher natural gas costs
- New power purchase agreements
- New and renewed transmission contracts
- Decreasing customer electricity usage

These cost increases are offset by a decrease in expenses from the shutdown of two coal-fired steam plants in Montana, Colstrip Units 1 and 2.

The UTC has the authority to approve rates which may be higher or lower than our request. New rates are expected to become effective upon completion of the UTC's examination of our proposed rates in June 2021.
