BACKGROUND

1 RCW 82.14B.030 requires the Washington Utilities and Transportation Commission (Commission) to determine on an annual basis the amount of the Enhanced 911 (E911) excise tax to be applied monthly to each switched access line. The level of the excise tax to be applied is to be based on the information and recommendation provided to the Commission by the state E911 coordinator.

2 On August 22, 2003, the Military Department, Emergency Management Division (EMD), filed a request with the Commission to continue the State E911 wireline excise tax at the current rate of \$0.20 per switched access line per month in 2004. The state E911 excise tax was extended to wireless subscribers beginning January 1, 2003, at a fixed rate of \$0.20 per month per subscriber. This additional tax resource will be utilized to implement new location technologies for wireless E911. The total tax collections for both wireline and wireless services are anticipated to be \$15.5 million in concert

with the Legislative appropriation for GY 2003-04. The wireline revenue is anticipated to be \$8.5 million of the total revenue. New rules developed by the EMD Program Office in 2003 require wireless and wireline funds be kept separate, except for common portions of the E911 network that are supported by both wireless and wireline customers.

FINDINGS AND CONCLUSIONS

- 3 (1) RCW 82.14B.030 (4) states, "By August 31st of each year the state enhanced 911 coordinator shall recommend the level for the next year of the state enhanced 911 excise tax, based on a systematic cost and revenue analysis, to the Utilities and Transportation Commission. The Commission shall by the following October 31st determine the level of the state enhanced 911 excise tax for the following year." The amount of tax shall not exceed twenty cents per month for each switched access line, as established through legislation.
- 4 (2) On August 27, 2003, EMD submitted to the Commission, their annual report of revenues, expenditures, and budgets relating to the statewide provision of the E911 service. EMD has recommended the continuation of the current excise tax of \$0.20 per switched access line per month.
- 5 (3) This matter was brought before the Commission at its regularly scheduled open meeting held on October 8, 2003.

- 6 (4) The Commission Staff investigated the filing and recommended the Commission determine the appropriate level of tax to be \$0.20.
- 7 (5) Continuation of the state E911 excise tax of \$0.20 is necessary due to implementation of location capability, supporting, maintaining, and upgrading the operations for E911 services statewide.

ORDER

THE COMMISSION ORDERS:

- 8 (1) Each local exchange telephone company shall collect a state Enhanced 911 excise tax in the amount of \$0.20 per switched access line per month, and pursuant to RCW 82.14B.030, shall remit the amount collected directly to the Department of Revenue on a tax return provided by the Department of Revenue.

The Commissioners, having been fully advised in the matter, and having determined this Order to be consistent with the public interest, directed the Secretary to enter the Order.
