Tariff/Schedule No. 35 has already been approved by the UTC for daily "spring" service between Seattle and Friday Harbor, beginning May 21, 2004. Due to fast rising fuel costs industry wide, the company desires to make a *modest* increase to its already approved spring fares, as set forth on Revised Page 3. Revised Page 3 reflects an increase over the existing approved tariff as follows: \$.25 for all child fares, \$.75 for one-way adult fares, and \$1.50 for round-trip adult fares.

Please place the REVISED PAGE 3 on the agenda for the May 12, 2004 meeting and consider our request for a change with less than statutory notice.
