RE: Rulemaking to Consider Possible Corrections and Changes to Selected Rules in Chapter 480-93 WAC, Gas Companies - Safety. Docket PG-061027

On July 19, 2006, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible corrections and changes to selected rules in Chapter 480-93 WAC, Gas Companies—Safety, specifically addressing WAC 480-93-005, WAC 480-93-013, WAC 480-93-015, WAC 480-93-017, WAC 480-93-018, WAC 480-93-100, WAC 480-93-124, WAC 480-93-170, WAC 480-93-180, WAC 480-93-188, WAC 480-93-200, and the potential addition of new rule(s). The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at www.wutc.wa.gov/061027. On May 5, 2005, the Commission completed a comprehensive review of its safety rules relating to natural gas pipeline operations. The safety rules in Chapter 480-93 WAC took effect on June 2, 2005. In November 2005, the Commission adopted changes to these rules to correct errors and clarify issues identified by agency staff and stakeholders. In the process of implementing these rules and recent amendments, stakeholders and agency staff have identified some additional concerns and areas that need to be clarified for those rules listed above. This rulemaking will consider revisions to the specific rules identified above.

Written comments addressing proposed changes to WAC 480-93-005, WAC 480-93-013, WAC 480-93-015, WAC 480-93-017, WAC 480-93-018, WAC 480-93-100, WAC 480-93-124, WAC 480-93-170, WAC 480-93-180, WAC 480-93-188, and WAC 480-93-200 in Chapter 480-93 WAC must be filed with the Commission no later than <u>Monday, August 21, 2006</u>.
