

PREPROPOSAL STATEMENT OF INQUIRY

CR-101 (June 2004)

(Implements RCW 34.05.310)
Do NOT use for expedited rule making

Agency: WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION

Subject of possible rule making: This rulemaking would consider possible corrections and clarifications to selected sections of Chapter 480-93 WAC, "Gas Companies – Safety," rules governing natural gas pipeline operators, specifically rules that need to reflect changes in RCW Title 80 and 81 resulting from the passage of Substitute Senate Bill 5225 during the 2007 legislative session. The rulemaking has been assigned Docket PG-070975.

Statutes authorizing the agency to adopt rules on this subject:

RCW 80.01.040(4), RCW 81.01.010, RCW 81.04.160, RCW 81.88.040, RCW 80.28.010(2), RCW 80.28.020, and Laws of 2007, ch. 142, § 1, § 2, and § 5.

Reasons why rules on this subject may be needed and what they might accomplish: The Washington Utilities and Transportation Commission (UTC) has identified several rules that should be modified to reflect statutory changes in the 2007 legislative session. Chapter 480-93 WAC, governing gas safety rules, requires amendments to update definitions and provisions governing penalties. This rulemaking will modify most rules in Chapter 480-93 WAC.
