DECLARATION OF JENNIFER MOFFATT KELLEY

I, Jennifer Moffatt Kelley, hereby declare as follows:

- 1. I am the Manager of Customer and Community Communications and I submit this declaration in support of PacifiCorp's compliance with WAC 480-100-194 for tariff filing UE-071016 which has a requested effective date of June 7, 2007.
- 2. On May 29, 2007, a copy of the notice was published in the Sunnyside Daily News, Walla Walla Union Bulletin and Yakima Herald. On May 31, 2007, a copy of the notice will run in the following weekly publications including the Dayton Chronicle, Grandview Herald, Pomeroy East Washington, Toppenish/Wapato Review Independent, and Waitsburg Times.
- 3. On May 31, 2007, a copy of the notice was provided by email to the Northwest Community Action Center in Toppenish, the Opportunities Industrialization Center of Washington in Yakima, and the Blue Mountain Action Council in Walla Walla.
- 4. On May 31, 2007, a press release summarizing the notice was provided in radio and television stations and community newspapers in the affected geographic area.

- 6. Approximately 108,000 customers will be affected by the tariff change.

EXHIBIT A

Pacific Power files to reduce BPA credit

On May 3, 2007, the United States Ninth Circuit Court of Appeals issued a decision that concluded that the Residential Exchange Program 2000 Settlement Agreement for Fiscal Year 2002-2006 was inconsistent with the Pacific Northwest Electric Power Planning and Conservation Act. As a result of this decision the BPA announced on May 21, 2007 that it will cease providing payments to the investor-owned utilities – including Pacific Power – under the Residential Exchange Program.

On May 23, in response to BPA's announcement, Pacific Power filed with the Washington Utilities & Transportation Commission to reduce the BPA Credit (Schedule 98) applied to residential and qualifying small-farm customers from 0.884 cents per kWh to 0.00 cents per kWh.

The BPA credit provides residential and qualifying small-farm Pacific Power customers with a direct pass-through of monetary benefits received from the Bonneville Power Administration (BPA) under the Residential Exchange Program. BPA has announced that it is ceasing to pay these benefits; thus, the effect of this revision is to reduce the level of credits provided to Pacific Power's eligible customers.

In accordance with WAC 480-80-122, the Company is requesting this filing become effective with less than statutory notice for service rendered on and after June 1, 2007. The monthly bill impact of this filing on an average Washington residential customer using 1300 kWh will be \$11.49. The Commission has the authority to set final rates that may vary from the utility's request (either higher or lower).
