- 1 On July 25, 2007, Jorge Nunez & Pedro Nunez filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a common carrier in the state of Washington as required by the provisions of RCW 81.80 and WAC 480-14. Jorge Nunez & Pedro Nunez’s application is incomplete as it lacks the Uniform Motor Carrier Certificate of Insurance (Form E).

- 2 The Commission sent Jorge Nunez & Pedro Nunez a notice to comply with the application requirements set forth in RCW 81.80 and WAC 480-14. Jorge Nunez & Pedro Nunez has not met these requirements as of the date of this Order.

- 3 The application filed by Jorge Nunez & Pedro Nunez in Docket TV-071567 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-14.

ORDER

- 4 **THE COMMISSION ORDERS** That the application filed by Jorge Nunez & Pedro Nunez in Docket TV-071567 for common carrier authority is dismissed.

- 5 The Commissioners have delegated authority to the Executive Secretary to enter this Order pursuant to RCW 80.01.030 and WAC 480-07-905(1)(g).
