- 1 On February 19, 2008, Julio Jimenez, d/b/a JLS Trucking, filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a common carrier in the state of Washington as required by the provisions of RCW 81.80 and WAC 480-14. Julio Jimenez's application is incomplete as it lacks a Uniform Motor Carrier Certificate of Insurance (Form E).
- 2 The Commission sent Julio Jimenez, d/b/a JLS Trucking, a notice to comply with the application requirements set forth in RCW 81.80 and WAC 480-14. Julio Jimenez, d/b/a JLS Trucking, has not met these requirements as of the date of this Order.
- 3 The application filed by Julio Jimenez, d/b/a JLS Trucking, in Docket TV-080314 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-14.

ORDER

- 4 **THE COMMISSION ORDERS** That the application filed by Julio Jimenez, d/b/a JLS Trucking, in Docket TV-080314 for common carrier authority is dismissed.
- 5 The Commissioners have delegated authority to the Executive Secretary to enter this Order pursuant to RCW 80.01.030 and WAC 480-07-905(1)(g).
