Distribution System Maintenance Charge

To all customers receiving service under Schedule 1 or Schedule 7.

Monthly Rates

\$5.00 monthly

Conditions

Money generated under this Schedule will be used to replace portions of the company's distribution system. Expenditures will be made with funds raised under this Schedule only after a plan for such expenditures has been approved by a majority vote of the Consumer Board. The Consumer Board shall consist of five members. One member will be chosen for the Northwest Division of the company's system which will consist of customers residing in the areas known as Davison Head, Neal Bay, Afterglow, Pearl Island, Tarte, Co House and Roche Harbor Heights. One member will be chosen from the Northeast Division of the company's system which will consist of customers residing in the areas known as Gull Cove, Bridal Trails Estates and RH Skyway. One member will be chosen for the Central area of the company's service area consisting of the Resort, Resort Development area and condos. One member will be chosen for the Southwest Division of the company's system which will consist of customers residing in the areas known as the Westcott Bay Park, Westcott Shores, Quarry Point, White Point Annex and Armdale Valley areas. One member will be chosen for the Southeast Division of the company's system which consists of customers residing in the areas known as Westcott Bay Estates, Roche Harbor Road and Bellevue Farms. Each member of the Consumer Board will serve a term of three years.
