The company requests Commission approval to amend its filed Tariff Number 16 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.018 per gallon for the base period (12 months ended March 31, 2005) to \$4.1467 per gallon current price.

1. The Commission finds good cause to support the request and authorizes the proposed changes to become effective with Less Than Statutory Notice on: November 1, 2008.
2. The proposed changes will expire on: March 31, 2009.
3. The temporary 1.96% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of July, August and September 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November, December, 2008 and January, 2009.

Customers who are billed quarterly for services – current month and two months in advance:
