According to Intelletrace, it is unable to prepare the report due to information not being readily available at this time. Intelletrace seeks an extension until May 31, 2009.		
Commission Staff reviewed the request and recommended granting Intelletrace's request for exemption.

- 7 (5) This matter came before the Commission at its regularly scheduled meeting on April 30, 2009.
- 8 (6) After reviewing the petition Intelletrace filed in Docket UT-090577 on April 23, 2009, and giving due consideration, the Commission finds that the exemption is in the public interest and is consistent with the purposes underlying the regulation and applicable statutes and should be granted.

## ORDER

## THE COMMISSION ORDERS:

- 9 (1) The request by Intelletrace, Inc., for an exemption from WAC 480-120-382 and for an extension until May 31, 2009, to file its 2008 annual report is granted.
- 10 (2) Failure by Intelletrace, Inc., to file its annual report by May 31, 2009, may result in the Commission invoking RCW 80.04.405, which allows the Commission to assess penalties for violations of statute, rules and Commission orders.
- 11 (3) The Commission retains jurisdiction over the subject matter and Intelletrace, Inc., to effectuate the provisions of this Order.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Executive Director and Secretary to enter this Order.
