The purpose of this filing is to provide substitute tariff sheets reflecting elimination of the price increases over the next five years that were designed to phase-in the impact of the proposed change. The Company recently became aware of an objection to this phase-in and discussed this filing with the objecting party. That party agreed that the Company is free, in the future, to again propose the phase-in or some other level or type of penalty for failure to comply with a curtailment request. The Company intends to attempt to resolve any disagreement and make a filing in the future to provide sufficient incentive to customers to curtail so that the system is protected from loss/failure due to failure to curtail when requested. PSE has also discussed these proposed substitute tariff sheets with the Commission's Staff.

The enclosed substitute tariff sheets reflect issue dates of August 4, 2009, and effective dates of September 4, 2009. These substitute tariff sheets do not increase the rates contained in the pending tariff sheets or make any material changes to the terms and conditions and are being made to reflect changes agreed upon with the Commission's Staff. Therefore, substitution should be allowed as provided in WAC 480-80-111(1) (a) and (b).
