1 On September 17, 2009, Ramon C Carreon, d/b/a Carreon Trucking (Mr. Carreon) filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a common carrier in the state of Washington under RCW 81.80 and WAC 480-14. Mr. Carreon’s application is incomplete as it lacks the names and positions of people responsible for understanding, maintaining and complying with current Federal Motor Carrier Safety Regulations for driver qualifications, hours of duty, and maintenance & inspection.

2 On September 17, 2009, and November 10, 2009, the Commission sent Mr. Carreon notices to comply with the application requirements set forth in RCW 81.80 and WAC 480-14. Mr. Carreon has not met these requirements as of the date of this Order.

3 The application filed by Mr. Carreon in Docket TV-091484 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-14.

ORDER

4 **THE COMMISSION ORDERS** the application filed by Ramon C Carreon, d/b/a Carreon Trucking, on September 17, 2009 in Docket TV-091484 for common carrier authority is dismissed.

5 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c).

and WAC 480-07-903(1)(c). You may seek Commission review of this decision by filing a request for Commission review of this order no later than twenty (20) days after the service date of the order.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.
