Registration and Competitive Classification of Telecommunication Companies

Ladies and Gentlemen:

On behalf of Grasshopper Group, LLC ("Grasshopper"), transmitted herewith are both PUBLIC and CONFIDENTIAL versions of its Registration and Competitive Classification of Telecommunications Companies ("Registration").

Grasshopper respectfully requests confidential treatment of the financial statements submitted in connection with its Registration. Grasshopper respectfully requests the Commission afford perpetual and continuing confidential treatment of certain financial information submitted in connection with Grasshopper's Registration. The financial information for which confidential treatment is requested pertains to Grasshopper's consolidated balance sheet, income statement, and cash flow statement for the first three quarters of 2009 and any and all information derived therefrom, and includes information pertaining to its unregulated services. The information for which Grasshopper seeks confidential treat is specifically included in the definition of confidential information in WAC 480-07-160(2). Each page of the confidential material is marked "CONFIDENTIAL PER WAC 480-07-160" in the Confidential version of its submission. The confidential materials have been redacted from the Public Version of its submission with the first page of the filing marked as "PUBLIC VERSION."

As a privately held company, Grasshopper is not under any obligation to prepare or release public financial statements. The disclosure of Grasshopper's financial information in the context of its registration or otherwise could provide competitors with valuable insight into Grasshopper's financial structure and planned operations. Because this represents highly confidential and strictly proprietary information, the disclosure of which to the public, including competitors, could result in direct and immediate harm to Grasshopper's competitive position, there is a genuine need for Grasshopper to seek non-disclosure of this information.

While the Commission needs to review this information to determine and confirm the merits of the Registration submitted, the general public has no direct or substantive interest in this information. Grasshopper's competitors also do not require this information other than to gain potential competitive advantage or to use the information in an unfair and potentially anticompetitive manner.

The enduring policies of the state have been to encourage and support competition in telecommunications. Essential to the proper workings of that policy is the maintenance of a level playing field in which competitors are made to compete on their own merits relative to price, service quality, innovation and customer service. Allowing access to one competitor's commercially sensitive information runs contrary to these principles and, hence, would not serve the public interest.

To the Company's knowledge, the information sought to be protected has not been made public in any other forum or jurisdiction. Grasshopper is seeking in other jurisdictions similar protective orders to safeguard the confidentiality of this information.

Accordingly, Grasshopper respectfully requests the Commission afford confidential treatment of the financial information submitted in the Confidential version of its Registration.
