BACKGROUND

- 1 On November 30, 2009, City of Ellensburg (Petitioner) filed with the Washington Utilities and Transportation Commission (Commission), a petition seeking approval to upgrade warning devices at a railroad-highway grade crossing. The crossing is identified as USDOT 085185U and is located at the intersection of Mountain View Avenue and BNSF Railway Co.'s (BNSF Railway) tracks in the City of Ellensburg. The Petitioner further requested the Commission authorize an expenditure of \$10,000 from the Grade Crossing Protective Fund (GCPF) to pay for the upgrades.

- 2 Railroad warning devices at the crossing consist of flashing lights. The Petitioner proposes to replace the obsolete incandescent lights with LED type lights. These upgrades will improve the overall safety at the crossing because motorists and pedestrians can rely on these active warning devices to determine if a train is approaching the crossing. The LED flashing lights will provide greater visibility for the motoring public.

- 3 The Petitioner is requesting a disbursement of \$10,000 to pay for the upgrades. An expenditure of \$10,000 from the Grade Crossing Protective Fund is available to help fund the improvements.

FINDINGS AND CONCLUSIONS

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having jurisdiction over public railroad-highway grade crossings within the state of Washington, and authority to approve and administer disbursements from the Grade Crossing Protective Fund. *RCW 81.53*; *RCW 81.53.271*; *RCW 81.53.281*.
- 5 (2) The grade crossing at the intersection of Mountain View Avenue and the Respondent's tracks in the City of Ellensburg, Washington, identified as USDOT 085185U, is a public railroad-highway grade crossing within the state of Washington.
- 6 (3) *RCW 81.53.261* requires the Commission grant approval prior to any changes to public railroad-highway grade crossings within the state of Washington. *See also WAC 480-62-150*.
- 7 (4) *RCW 81.53.271* allows the Commission to disburse up to \$20,000 from the Grade Crossing Protective Fund to pay for the installation of a grade crossing protective device, without requiring the Petitioner to share the cost.
- 8 (5) Commission Staff investigated the petition and recommended that it be granted, subject to specified conditions.
- 9 (6) After reviewing the City of Ellensburg's petition filed on November 30, 2009, and giving due consideration to all relevant matters and for good cause shown, the Commission grants the petition and request for disbursement of funds.

ORDER

THE COMMISSION ORDERS:

- 10 The City of Ellensburg's petition to upgrade warning devices at a railroad-highway grade crossing, located at the intersection of Mountain View Avenue and the Respondent's tracks in the City of Ellensburg, Washington, is granted. The cost of this upgrade shall be paid from the Grade Crossing Protective Fund. Approval of the petition is subject to the following conditions:

- (1) Expenditure from the Grade Crossing Protective Fund must not exceed \$10,000.
- (2) Payment will be made upon presentation of claim for reimbursement for materials and labor, and verification by Commission Staff that the work has been satisfactorily completed.
- (3) City of Ellensburg must sign and return the attached project agreement.
- (4) The project must be completed no later than March 1, 2011.
- (5) Traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation *Manual on Uniform Traffic Control Devices*.
- (6) City of Ellensburg must notify the Commission on completion of the upgrades authorized in this Order. Acceptance of the upgrades is subject to inspection by Commission Staff, and verification that the crossing is in full compliance with applicable laws, regulations, and the conditions specified in this Order.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
