- 1 On February 1, 2010, A+ Pacific Limousine, (A+ Pacific Limousine), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to provide charter and excursion carrier service in the state of Washington under RCW 81.70. A+ Pacific Limousine's application is incomplete as it lacks a Unified Business Identifier Number, a USDOT number and insurance.
- 2 On February 2 and April 14, 2010, the Commission sent A+ Pacific Limousine a notice to comply with the application requirements in RCW 81.70 and WAC 480-30. A+ Pacific Limousine has not met these requirements as of the date of this Order.
- <sup>3</sup> The application filed by A+ Pacific Limousine in Docket TE-100188 should be dismissed for failure to meet the application requirements in RCW 81.70 and WAC 480-30.
