BACKGROUND		
The Commission imposes an annual pipeline safety fee pursuant to RCW 80.24.060 and RCW 81.24.090 to meet the costs of its pipeline safety program. RCW 80.24.060(1) requires that every gas company and every interstate gas pipeline company subject to inspection or enforcement by the Commission must pay an annual pipeline safety fee to the Commission. RCW 81.24.090(1) requires that every hazardous liquid pipeline company as defined in RCW 81.88.010 must pay an annual pipeline safety fee to the Commission. The fee is determined by the fee methodology established in WAC 480-93-240 (gas) and WAC 480-75-240 (hazardous liquid).		
The fees set by the Commission are paid quarterly, beginning September 1 of each year. On July 31, 2010, the Commission mailed invoices to each company showing the total amount of the pipeline fee for fiscal year 2011, and the first quarterly payment amount due September 1, 2010.		
	FINDING	S OF FACT
(1)	The Commission has determined each company's fiscal 2011 fee pursuant to RCW 80.24.060 and WAC 480-93-240 (gas pipeline companies and interstate gas pipeline companies), and RCW 81.24.090 and WAC 480-75-240 (hazardous liquid pipeline companies).	
(2)	The Commission deducts from the t	otal program cost (\$1,900,000) the federal

- 14 (3) Pursuant to RCW 80.24.060(7) and RCW 81.24.090(7), any entity seeking to contest the imposition of the fees established by this Order must pay the fee and request a refund within six months of the due date of the fee. The procedures are described in WAC 480-93-240(5) and WAC 480-75-240(5).
