**RE:** Tariff Revision

Dear Mr. Powers:

On July 19, 2010, Suncadia Water Company, LLC, filed with the Utilities and Transportation Commission a Tariff Revision. The filing has been docketed under UW-101323.

The filing did not include information required by the Commission. Specifically, the filing must include the following:

- Support material for general rate increase required by WAC 480-07-530 and WAC 480-80-105. Customer Notice required by WAC 480-110-425.
- The commission must receive tariff changes not less than thirty days in advance of the requested effective date as required by WAC 480-80-121.

WAC 480-07-141 states that the Commission may reject a filing if it is insufficient or defective. Therefore, the company's request filed on July 19, 2010, is rejected in its entirety. However, be advised that the company may re-file a complete filing reflecting the new issue and effective dates.
