- On September 14, 2010, Dario Pruneda, d/b/a Dario Pruneda & Sons Trucking (Mr. Pruneda) filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a common carrier in the state of Washington under RCW 81.80 and WAC 480-14. Mr. Pruneda's application is incomplete as it lacks the Uniform Motor Carrier certificate of Insurance, mailing and physical addresses, and the trade name is not registered with Department of Licensing.
- 2 On September 16 and October 7, 2010, the Commission sent Mr. Pruneda notices to comply with the application requirements set forth in RCW 81.80 and WAC 480-14. Mr. Pruneda has not met these requirements as of the date of this Order.
- The application filed by Mr. Pruneda in Docket TV-101527 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-14.
