The company requests Commission approval to amend its filed Tariff Number 10 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.6818 per gallon for the base period to \$4.1526 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 17 in the amount of 3.19%.
