1 On June 16, 2011, Charles Bartlett, d/b/a Affordable Haulers and Movers, (Charles Bartlett or Applicant), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a household goods carrier in the state of Washington under RCW 81.80 and WAC 480-15. Charles Bartlett’s application is incomplete as it lacks registrations with Washington State Labor & Industries and Employment Security departments, and did not provide the Uniform Motor Carrier Certificate of Insurance (Form E).

2 On June 20<sup>th</sup>, July 21<sup>st</sup> and August 22, 2011, the Commission sent Charles Bartlett notices to comply with the application requirements in RCW 81.80 and WAC 480.15. Charles Bartlett has not met these requirements as of the date of this Order.

3 The application filed by Charles Bartlett in Docket TV-111115 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-15.

**ORDER**

4 **THE COMMISSION ORDERS** the application filed by Charles Bartlett, d/b/a Affordable Haulers and Movers, on June 16, 2011 in Docket TV-111115 for household goods carrier authority is dismissed.

5 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(1)(k).

**NOTICE:** This is an order delegated to the Secretary for decision. In addition to serving you a copy of the decision, the Commission will post on its Internet Web site for at least 14 days a listing of all matters delegated to the Secretary for decision. You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
