1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: November 1, 2011.
2. The proposed changes will expire on: December 31, 2011.
3. The temporary .60% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of August 2011 and September 2011, to be collected from customers as follows:
