BACKGROUND

- On February 1, 2012, Puget Sound & Pacific Railroad (PSAP or Petitioner) filed with the Washington Utilities and Transportation Commission (Commission), a petition seeking approval to modify active warning devices at a railroad-highway grade crossing. The crossing is identified as USDOT 808713U and is located at the intersection of West First Street and the Petitioner's tracks in the City of Aberdeen. The Petitioner further requested the Commission authorize an expenditure of \$20,000 from the Grade Crossing Protective Fund (GCPF) to pay for a portion of the upgrades.
- Railroad warning devices at the West First Street crossing consist of shoulder-mounted flashing lights and cross-bucks. The Petitioner proposes to upgrade the crossing surface of the spur line to concrete, replace the underground cable, and replace all signal equipment which includes upgrading from incandescent flashing lights to LED. The signal equipment to be installed is also equipped with gates. In addition, the train detection will be upgraded from AC DC to constant warning. These upgrades will improve the overall safety at the crossing because motorists and pedestrians can rely on these active warning devices to determine if a train is approaching the crossing. The LED flashing lights will provide greater visibility for the motoring public.
- West First Street is a two-lane roadway with a posted speed limit of 25 miles per hour. Average daily traffic through the crossing is estimated at 3,990 vehicles. No school buses travel over this crossing and it is not a designated truck route.

The Petitioner is requesting a disbursement of \$20,000 to pay for a portion of the upgrades. The total approximate cost of the project is \$43,145. The Petitioner has committed to pay upgrades in excess of \$20,000. Commission Staff is facilitating the use of surplus equipment at this crossing. An expenditure of \$20,000 from the Grade Crossing Protective Fund is available to help fund the improvements.

FINDINGS AND CONCLUSIONS

- The Washington Utilities and Transportation Commission is an agency of the State of Washington having jurisdiction over public railroad-highway grade crossings within the state of Washington, and authority to approve and administer disbursements from the Grade Crossing Protective Fund. *RCW* 81.53; *RCW* 81.53.271; *RCW* 81.53.281.
- 6 (2) The grade crossing at the West First Street, identified as USDOT 808713U, is a public railroad-highway grade crossing within the state of Washington.
- 7 (3) RCW 81.53.261 requires the Commission grant approval prior to any changes to public railroad-highway grade crossings within the state of Washington. *See also WAC 480-62-150*.
- 8 (4) RCW 81.53.271 allows the Commission to disburse up to \$20,000 from the Grade Crossing Protective Fund to pay for the installation of a grade crossing protective device, without requiring the Petitioner to share the cost.
- 9 (5) Commission Staff investigated the petition and recommended that it be granted, subject to specified conditions.
- 10 (6) After reviewing PSAP's petition filed on February 1, 2012, and giving due consideration to all relevant matters and for good cause shown, the Commission grants the petition and request for disbursement of funds.

ORDER

THE COMMISSION ORDERS:

Puget Sound & Pacific Railroad's petition to upgrade warning devices at a railroadhighway grade crossing, located at the West First Street, is granted. The cost of a portion of this upgrade shall be paid from the Grade Crossing Protective Fund. Approval of the petition is subject to the following conditions:

- (1) Expenditure from the Grade Crossing Protective Fund must not exceed \$20,000.
- (2) Payment will be made upon presentation of claim for reimbursement for materials and labor, and verification by Commission Staff that the work has been satisfactorily completed.
- (3) Puget Sound & Pacific Railroad must sign and return the attached project agreement.
- (4) The project must be completed no later than December 30, 2012.
- (5) Traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation *Manual on Uniform Traffic Control Devices*.
- (6) Puget Sound & Pacific Railroad must notify the Commission on completion of the upgrades authorized in this Order. Acceptance of the upgrades is subject to inspection by Commission Staff, and verification that the crossing is in full compliance with applicable laws, regulations, and the conditions specified in this Order.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
