Dear Valued Commercial Customer.

This is to notify you of a proposed rate change for commercial services in the Allied Waste of Lynnwood areas of Snohomish County. Should the Washington Utilities and Transportation Commission (Commission) approve our request customers will experience an overall rate increase throughout all classes of service.

As you may know, it has been nearly two years since our last general rate case. In that time Allied Waste of Lynnwood has experienced increases in all of the costs key to delivering our services; including labor, fuel and maintenance costs. In addition, the company continues to invest in new assets to ensure it can deliver the safest, most efficient service possible. If approved, the proposed rates will become effective July 1, 2012.
