- On July 16, 2012, Lawrence Brooks, Jr., d/b/a Brooks Professional Moving, (Brooks Professional Moving or Applicant), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a household goods carrier in the state of Washington under RCW 81.80 and WAC 480-15. Brooks Professional Moving's application is incomplete. It lacks registration with Department of Labor & Industries and Employment Security Department, USDOT number, and a Uniform Motor Carrier Certificate of Insurance (Form E).
- 2 On July 19, August 30, October 15, and November 29, 2012, the Commission sent Brooks Professional Moving notices to comply with the application requirements in RCW 81.80 and WAC 480.15. Brooks Professional Moving has not met these requirements as of the date of this Order.
- The application filed by Brooks Professional Moving in Docket TV-121192 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-15.

- 4 **THE COMMISSION ORDERS** the application filed by Lawrence Brooks, Jr., d/b/a Brooks Professional Moving, on July 16, 2012, in Docket TV-121192 for household goods carrier authority is dismissed.
