- 1 On August 16, 2012, Rogelio Salas, d/b/a Salas Tapia Transport, (Salas Tapia Transport), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a common carrier in the state of Washington under RCW 81.80 and WAC 480-14. Salas Tapia Transport’s application is incomplete as it lacks a Unified Business Identifier (UBI) number and a Uniform Motor Carrier Certificate of Insurance (Form E).

- 2 On August 17, September 27, and October 25, 2012, the Commission sent Salas Tapia Transport notices to comply with the application requirements set forth in RCW 81.80 and WAC 480-14. Salas Tapia Transport has not met these requirements as of the date of this Order.

- 3 The application filed by Salas Tapia Transport in Docket TV-121364 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-14.

ORDER

- 4 **THE COMMISSION ORDERS** the application filed by Rogelio Salas, d/b/a Salas Tapia Transport, on August 16, 2012 in Docket TV-121364 for common carrier authority is dismissed.

- 5 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-903(1)(c).

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.
