- 1 On September 18, 2012, Rick D. Clark, d/b/a Rick Clark Trucking, (Rick Clark Trucking) filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to operate as a common carrier in the state of Washington under RCW 81.80 and WAC 480-14. Rick Clark Trucking’s application is incomplete as it lacks a current Department of Revenue account and a Uniform Motor Carrier Certificate of Insurance (Form E).
- 2 On September 21, October 25, and November 26, 2012, the Commission sent Rick Clark Trucking notices to comply with the application requirements set forth in RCW 81.80 and WAC 480-14. Rick Clark Trucking has not met these requirements as of the date of this Order.
- 3 The application filed by Rick Clark Trucking in Docket TV-121537 should be dismissed for failure to meet the application requirements in RCW 81.80 and WAC 480-14.

ORDER

- 4 **THE COMMISSION ORDERS** the application filed by Rick D. Clark, d/b/a Rick Clark Trucking, on September 18, 2012 in Docket TV-121537 for common carrier authority is dismissed.
- 5 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-903(1)(c).

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.
