Motor freight carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission), must file and maintain proof of liability and property damage insurance.

- 2 On October 15, 2012, the Commission notified you by letter that your permit to operate as a motor freight carrier in Washington would be suspended if your insurance company did not file with the Commission acceptable proof of insurance. We also informed you that you could contest suspension of your permit by requesting a hearing within 10 days of the notice.
- 3 The Commission has not received proof of insurance and you have not requested a hearing.

FINDINGS AND CONCLUSION

- The Washington Utilities and Transportation Commission is an agency of the (1)State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- Betty Fahsholtz, d/b/a Fahsholtz Farms, (Fahsholtz Farms), is a motor freight 5 (2)carrier operating in Washington state under permit CC-61310.
