Pursuant to WAC 480-100-198, Notice Verification and Assistance, Puget Sound Energy (the "Company") is providing this statement that it will publish the a notice in the above-referenced dockets in accordance with WAC 480-100-194, Publication of Proposed Tariff Changes to Increase Charges or Restrict Access to Services.

On February 28, 2013 Puget Sound Energy, Inc. (the "Company") filed with the Commission electric Schedule 120, Electricity Conservation Service Rider. The requested effective date on the filing was sixty two (62) days following the filing date or May 1, 2013. Most of the Company's approximately 1,093,200 customers receiving electric service will see an increase in their bill due to the proposed change and approximately 124 customers will see a decrease and 17 no change in rates. Pursuant to WAC 480-100-198, Notice Verification and Assistance, the Company is providing this statement that it has posted the above-referenced filing in accordance with WAC 480-100-193(1), Posting of Tariffs for Public Inspection and Review; Web, Telephone, and Mail Access.

The Company also states that notice to the public of the filing referenced above will be completed in accordance with WAC 480-100-194(2), Publication of Proposed Tariff Changes to Increase Charges or Restrict Access to Services; Published Notice, by providing notice in the form of a published notice in area newspapers. WAC 480-100-194(1) provides that notice to customers must be provided at least thirty days before the stated effective date which would be on or before March 31 whereas WAC 480-100-198 provides that notice to the commission must be made within ten days of filing, or in this case March 11. Because of this difference in date between the two WAC rules the notice attached to this letter is a draft. A copy of the published notice that appears in area newspapers will be provided following its publication in accordance with WAC 480-100-
