RATE INCREASE NOTICE FOR COMMERCIAL CONTAINER AND CAN SERVICES

Dear Customer:

April 30, 2013

Murrey's Disposal Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC March 1, 2010. Since that time, the Company has experienced increases in operating costs in the areas of labor, employee benefits, fuel, parts and equipment amongst other categories which it now seeks to update in rates.

If approved, the proposed rates will become effective June 1, 2013. The rate per pick-up will increase as follows:
