Dear Mr. King:

Enclosed you will find the above-referenced tariff sheets. The purpose of this filing is to modify the current rate design as required by the Commission Order in Docket UW-111399.

The filing does not produce additional revenue for the Company. It does, however, reduce residential rates by approximately 4 percent and increase non-residential rates by approximately 37 percent.

Therefore, the Company is making this filing pursuant to WAC 480-07-530.

Pursuant to WAC 480-07-530(4) the supporting work papers for the test period are included in the electronic attachment. Information describing the dollar change for each service category as well as the percentage change and the net impact is provided in the electronic attachment. WAC 480-07-530(4)(a). These work papers show a calculation of revenue impact of the proposed rates for each affected class.

A balance sheet and statement of revenues and expenses is also attached. WAC 480-07-530(4)(b). A depreciation schedule is attached. WAC 480-07-530(4)(c). There is also a schedule of adjustments showing restating and pro forma adjustments. WAC 480-07-530(4)(d).


Electronic work papers for the restating and pro forma adjustments are also attached. WAC 480-07-530(4)(e).
