- On April 8, 2013, Presidential Services LLC, (Presidential Services LLC), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to provide charter and excursion carrier service in the state of Washington under RCW 81.70. Presidential Services LLC's application is incomplete as it lacks a Uniform Motor Carrier Certificate of Insurance (Form E), correct name under USDOT number and a CVSA safety inspection of vehicles.
- On April 16, May 17, and June 19, 2013, the Commission sent Presidential Services LLC notices to comply with the application requirements in RCW 81.70 and WAC 480-30. Presidential Services LLC has not met these requirements as of the date of this Order.
- The application filed by Presidential Services LLC in Docket TE-130530 should be dismissed for failure to meet the application requirements in RCW 81.70 and WAC 480-30.

- THE COMMISSION ORDERS the application filed by Presidential Services LLC on April 8, 2013 in Docket TE-130530 for charter and party excursion carrier service is dismissed.
