BACKGROUND

- 1 On April 23, 2013, Common Point, LLC (Common Point or Company), filed with the Washington Utilities and Transportation Commission (Commission) a petition for an extension of time to file its annual report for 2012 as required by [WAC 480-120-382](#). According to Common Point, year-end financial statements will not be finalized and approved by the due date. Common Point seeks an extension until July 1, 2013. The Company paid its annual regulatory fee on May 1, 2013.
- 2 Commission Staff reviewed the request and recommends granting Common Point’s request for exemption.

FINDINGS AND CONCLUSIONS

- 3 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate public service companies, including competitively classified telecommunications companies. [RCW 80.01.040](#), [RCW 80.04](#) and [RCW 80.36](#).
- 4 (2) Common Point is a competitively classified telecommunications company and a public service company subject to Commission jurisdiction.
- 5 (3) Common Point is subject to [WAC 480-120-382](#), which requires competitively classified telecommunications companies to file an annual report no later than May 1 of each year.

- 6 (4) Under WAC [480-120-015](#), the Commission may grant an exemption from any rule in
WAC [480-120](#), if consistent with the public interest, the purposes underlying
regulation and applicable statutes. See also [WAC 480-07-110](#).
- 7 (5) This matter came before the Commission at its regularly scheduled meeting on
May 9, 2013.
- 8 (6) After review of the petition in Docket UT-130588 by Common Point filed on
April 23, 2013, and giving due consideration, the Commission finds that the
exemption is in the public interest and is consistent with the purposes underlying the
regulation and applicable statutes and should be granted.

ORDER

THE COMMISSION ORDERS:

- 9 (1) The request by Common Point, LLC, for an exemption from WAC 480-120-382 and
for an extension until July 1, 2013, to file its 2012 annual report is granted.
- 10 (2) Failure by Common Point, LLC, to file its annual report by July 1, 2013, may
result in the Commission invoking [RCW 80.04.405](#), which allows the
Commission to assess penalties for violations of statute, rules and Commission
orders.
- 11 (3) The Commission retains jurisdiction over the subject matter and Common Point,
LLC, to effectuate the provisions of this Order.

The Commissioners, having determined this Order to be consistent with the public interest,
directed the Secretary to enter this Order.
