**BACKGROUND**

- 1 On April 30, 2013, Ada-Lin Waste Systems, Inc. dba Sunshine Disposal & Recycling (Ada-Lin or Company) filed with the Washington Utilities and Transportation Commission (Commission) a petition requesting an extension of time to file its 2012 annual report as required by WAC 480-70-071. Ada-Lin paid its regulatory fee on April 30, prior to the May 1 due date in WAC 480-70-076(2). Ada-Lin seeks an extension until July 1, 2013.
- 2 Commission Staff reviewed the request and recommended granting Ada-Lin’s request for exemption, subject to the condition that Ada-Lin files its annual report no later than July 1, 2013.

**FINDINGS AND CONCLUSIONS**

- 3 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate the rates, rules, regulations, practices, accounts and affiliated interests of public service companies, including solid waste companies. RCW 80.01.040, RCW 81.01, RCW 81.04, RCW 81.16, RCW 81.28 and RCW 81.77.
- 4 (2) Ada-Lin is a solid waste company and a public service company subject to Commission jurisdiction.
- 5 (3) Ada-Lin is subject to WAC 480-70-071, which requires solid waste companies to file an annual report by May 1 of each year.

- 6 (4) Under WAC 480-70-071 (1)(c), the Commission may grant an extension of time allowing the Company to file its annual report after the May 1 due date if the Commission receives a request for extension before May 1.
- 7 (5) This matter came before the Commission at its regularly scheduled meeting on May 30, 2013.
- 8 (6) After review of the petition filed in Docket TG-130651 by Ada-Lin on April 30, 2013, and giving due consideration, the Commission finds that the exemption is in the public interest and is consistent with the purposes underlying the regulation and applicable statutes and should be granted.

**O R D E R**

**THE COMMISSION ORDERS:**

- 9 (1) The request by Ada-Lin Waste Systems, Inc., dba Sunshine Disposal & Recycling for an exemption from WAC 480-70-071 and for an extension until July 1, 2013, to file its 2012 annual report is granted.
- 10 (2) Failure by Ada-Lin Waste Systems, Inc., dba Sunshine Disposal & Recycling to file its 2012 annual report by July 1, 2013, may result in the Commission invoking RCW 81.04.405, which allows the Commission to assess penalties for violations of statute, rule, and Commission orders.
- 11 (3) The Commission retains jurisdiction over the subject matter and Ada-Lin Waste Systems, Inc., dba Sunshine Disposal & Recycling to effectuate the provisions of this Order.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
