- 1 On February 25, 2014, Eastern Pioneer Group LLC, (Eastern Pioneer Group LLC), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to provide charter and excursion carrier service in the state of Washington under RCW 81.70. Eastern Pioneer Group LLC’s application is incomplete as it lacks a USDOT number in the correct name, a CVSA inspection of vehicles, and a Uniform Motor Carrier Certificate of Insurance (Form E).
- 2 On February 27, March 26, and April 28, 2014, the Commission sent Eastern Pioneer Group LLC notices to comply with the application requirements in RCW 81.70 and WAC 480-30. Eastern Pioneer Group LLC has not met these requirements as of the date of this Order.
- 3 The application filed by Eastern Pioneer Group LLC in Docket TE-140300 should be dismissed for failure to meet the application requirements in RCW 81.70 and WAC 480-30.

ORDER

- 4 **THE COMMISSION ORDERS** the application filed by Eastern Pioneer Group LLC on February 25, 2014 in Docket TE-140300 for charter and party excursion carrier service is dismissed.
- 5 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(5)(f).
