- On February 26, 2014, Good & Goods, LLC, d/b/a The Original Cannabus, (Good & Goods, LLC), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to provide charter and excursion carrier service in the state of Washington under RCW 81.70. Good & Goods, LLC's application is incomplete as it lacks a Uniform Motor Carrier Certificate of Insurance (Form E) as well as a CVSA safety inspection.
- On March 4, April 2, and May 7, 2014, the Commission sent Good & Goods, LLC notices to comply with the application requirements in RCW 81.70 and WAC 480-30. Good & Goods, LLC has not met these requirements as of the date of this Order.
- The application filed by Good & Goods, LLC in Docket TE-140332 should be dismissed for failure to meet the application requirements in RCW 81.70 and WAC 480-30.

## **ORDER**

- THE COMMISSION ORDERS the application filed by Good & Goods, LLC, d/b/a The Original Cannabus, on February 26, 2014 in Docket TE-140332 for charter and party excursion carrier service, is dismissed.
