

STOCK PURCHASE AGREEMENT

THIS AGREEMENT (the "Agreement") is entered into effective March 20, 2014, by and between Khadija Moosa, a single woman ("Purchaser"), and Elegant Limo, Inc. ("Corporation") and Zaheer Ahmed ("Shareholder").

RECITALS

A. The authorized capital stock of the Corporation is wholly owned by Zaheer Ahmed. There is no Preferred Stock presently authorized, held or outstanding.

B. In accordance with the terms and conditions of this Agreement, Purchaser desires to acquire from Shareholder, and the Shareholder desires to sell to Purchaser all capital stock of Corporation, representing a 100% ownership interest in Corporation.

AGREEMENT

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

DEFINED TERMS

The following capitalized terms, when used in this Agreement, shall have the meanings set forth below, unless the context clearly indicates otherwise.

0.1 "*Agreement*" means this Stock Purchase Agreement.

0.2 "*Closing*" means the closing of the purchase and sale of the Shares in accordance with this Agreement.

0.3 "*Closing Date*" means the date on which Closing will take place, as specified in Section 2.1.

0.4 "*Common Stock*" means all shares of voting common stock of the Corporation, which constitutes all of the shares of the Corporation's common stock.

0.5 "*Corporation*" means Elegant Limo, Inc., a Washington corporation.

0.6 "*Financial Statements*" means the Financial Statements of the Corporation referred to in Section 3.7.

0.7 "*Preferred Stock*" means authorized voting preferred stock of the Corporation, of which none exists.

0.8 "*Purchaser*" means Khadija Moosa, a single woman.



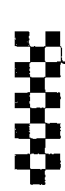
