Note 3: A gate or obstruction charge of \$ 15.50 will be assessed for opening, unlocking, or closing gates, or moving obstructions in order to pick up solid waste

Note 4: In addition to all other applicable charges, a charge of \$14.60 (A) per yard (assessed on a pro rata basis) will be assessed if containers are filled past their visible limit, container lids will not close due to overfilling or if additional materials are placed on or near the containers.

Note 5: If a customer requests a lockbar, an installation charge of \$25.00 shall apply.
