RATE INCREASE NOTICE FOR COMMERCIAL GARBAGE SERVICE

Dear Customer:

March 31, 2015

Yakima Waste Systems, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC January 1, 2014. Since that time, the Company has experienced increases in operating costs in the areas of labor, employee benefits, parts and equipment amongst other categories which it now seeks to update in rates.

If approved, the proposed rates will become effective May 1, 2015. The rate per pick-up will increase as follows:
