(3) Perjury in the first degree is a class B felony."

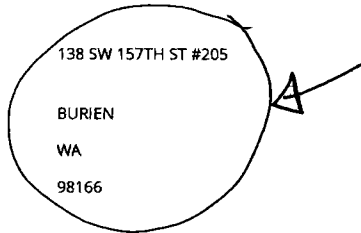
