Note 3: A gate or obstruction charge of **\$14.54** per pick up will be assessed for opening, unlocking or closing gates or moving obstructions in order to pick up solid waste.

Note 4: A lock fee of **\$3.92** will be assessed for unlocking padlocks or other locking devices on container to perform pick up service.

Note 5: In addition to all other applicable charges, a charge of **\$22.38** per yard (assessed on a pro rata basis) will be assessed if containers are filled past their visible full limit, container lids will not close due to overfilling, or if additional materials are placed on or near the containers.
