- On November 12, 2015, Johnson's Hauling LLC, d/b/a Johnson's Hauling & Moving, filed an application with the Washington Utilities and Transportation Commission (Commission) to reinstate its temporary household goods carrier authority in the state of Washington under RCW 81.80 and WAC 480-15, rules relating to motor carriers of household goods.
