BACKGROUND

- 1 Household goods carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance (Form E).
- 2 On December 3, 2015, the Commission notified Friendly Moving Service LLC (Company) by letter that its permit to operate as a household goods carrier in Washington would be cancelled if acceptable proof of insurance is not filed by January 7, 2016. The Commission also informed Friendly Moving Service LLC of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

DISCUSSION

- 3 The Commission has not received acceptable proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier's permit for failure to file and maintain proof of insurance. Permit HG-64181 should be cancelled.
- 4 To reinstate the permit, Friendly Moving Service LLC would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E) within 30 days. After 30 days, the applicant will be subject to all terms and conditions of a new entrant.

FINDINGS AND CONCLUSION

- 5 (1) The Washington Utilities and Transportation Commission is an agency of the
State of Washington having authority to regulate household goods carriers as
defined in RCW 81.80.
- 6 (2) Friendly Moving Service LLC is a household goods carrier operating in
Washington under permit HG-64181.
- 7 (3) On December 3, 2015, the Commission received notice of insurance
cancellation related to Friendly Moving Service LLC effective January 7,
2016. The Commission notified the Company that if a Form E insurance
certificate was not received by the cancellation date, its permit would be
cancelled.
- 8 (4) The Commission is authorized by WAC 480-15-450(1)(c) to cancel a
household goods carrier's permit for failure to file and maintain proof of
insurance.
- 9 (5) The Commission should cancel Friendly Moving Service LLC's household
goods carrier's permit for failure to file and maintain proof of insurance.

ORDER

THE COMMISSION ORDERS:

- 10 (1) Permit HG-64181 held by Friendly Moving Service LLC is cancelled as of
January 7, 2016.
- 11 (2) Friendly Moving Service LLC is directed to **cease** all operations associated
with permit HG-64181.
- 12 The Commission has delegated authority to the Secretary, or to the Secretary's
delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and
Order 04 in Docket A-090485.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
