The purpose of this filing is to convey PSE's annual compliance filing as provided in (1) Exhibit G to the Settlement Stipulation Agreement approved by the Commission in Docket Nos. UE-011570 and UG-011571 (the "Settlement") and (2) as provided in the Multiparty Settlement Stipulation in Docket No. U-072375 and the Partial Settlement in Docket Nos. UE-072300 and UG-072301 and (3) as ordered by the Commission in Order 08 in Docket Nos. UE-111048 and UG-111049 ("Order 08") and (4) as ordered by the Commission in Order 07 in Docket Nos. UE-121697 and UG-121705 (consolidated) issued jointly with Order 07 in Docket Nos. UE-130137 and UG-130138 (consolidated) ("Order 07").

The amount of change in the total electric revenue requirement over last year is a decrease of \$48,225. This revenue requirement results in an approximate average overall decrease to rates for electric customers of 0.007%. Not represented in the revenue requirement is an additional \$209,263 which has been made available in customer benefits as a result of PSE's 2016 SQI #5 penalty in Docket No. UE-072300. Details supporting the revised level of funding, revenue requirement and prior year collections are detailed in work papers provided directly to the Commission's staff.
