The Washington Utilities and Transportation Commission (Commission) has filed with the Code Reviser proposed revisions to the adoption-by-reference rules in Title 480 of the Washington Administrative Code (WAC). The Commission filed the proposed changes as an expedited rulemaking (CR-105) under Docket A-170015.

This proposal would revise adoption-by-reference dates to reflect the most current published versions of adopted federal rules and other adopted publications.
