To whom it may concern,

We, Seattle Ocean Travel, apply for mitigation for the following reasons:

- 1. We are new business, built up in April 2014. During our operation time, we try our best to obey the law and instruction as a Washington state transportation carrier. We consider safety for the driver and customer as the first important thing. That is the reason why we applied 5 million dollars' damage coverage for insurance, which requirement for this type of vehicle is 1 million dollars.
 - For one of the violation is using a commercial motor vehicle not periodically inspected. We apologized that due to the language barrier we misunderstand the meaning of the government required. We did the inspection every time before the driver drive and regular oil changed and multi point check. The mistake we made is we do not understand we should use the garage which have been approved by government.
- 2. When the officer did the inspection, we highly cooperated with the officers to find out the problem and fix them. From my point of view, the penalty is for an alert to remind us not make this mistake again. So, if there are a more training to tell us how to be a new transportation carrier and what we need to do in the first year. We are more than happy to join in. For a second language learner, paper document or checklist is more important than verbal training. We will keep them into our document to record, and consider it as the first important thing.
- 3. We are small business. The penalty, \$12,500 means a lot for us, it may even make us close the business. Because this 15 passengers bus is only for the Eva airlines crew pick up. We have contract with hotel and they only give us a very low payment. The yearly gross income for this is only around \$36000. And after paying for the labor salary, insurance fee, gas. Parking ticket and maintenance fee, loan etc. The net income is below \$5,000 a year. So, we sincerely make a request for mitigation.

We highly acknowledge that we should take our responsibility for the business. And we would learn every detail we should learn, and correct every mistake

we make. Since it is the first time we got violation and our situation. Please reconsider our case. We would like to cooperated and provide all evidence we could.
