PSE’s Electric Tariff Filing**

Dear Mr. King,

Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revisions to the WN U-60, Tariff G for electric service of Puget Sound Energy (“PSE”):

- 96<sup>th</sup> Revision of Sheet No. 81-A Schedule 81, Tax Adjustment (Continued)**
- 11<sup>th</sup> Revision of Sheet No. 81-C Schedule 81, Tax Adjustment (Continued)**

The purpose of this filing is to continue the current utility tax rate within the City of Medina (the “City”). A copy of the approved City ordinance, Ordinance 951, is enclosed.

The City of Medina ordinance extends the sunset of the 6 percent utility tax rate an additional year to January 31, 2019. Therefore there is no change to gross revenues.

PSE was not made aware of the enclosed city ordinance until yesterday. In order for the rate extension to be coincident with the effectiveness of the ordinance, PSE is requesting less than statutory notice (“LSN”) approval of this filing. Therefore, PSE respectfully requests that the Commission allow LSN effectiveness of this tariff change and allow it to become effective on January 31, 2018. A Commission LSN form documenting this request is attached.

The tariff sheets described herein reflect issue dates of January 19, 2018, and effective dates of February 19, 2018. As mentioned above, PSE has requested a LSN effective date of January 31, 2018, for this filing. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193.
