Cascade Natural Gas Corporation ("Cascade") hereby encloses for filing the following proposed tariff sheet containing a requested effective date of November 1, 2018:

Eighty-Fourth Revision Sheet No. 596 Canceling Eighty-Third Rev. Sheet No. 596

The purpose of the conservation program adjustment (CPA) filing is to pass on changes in the amount of conservation program expenditures affecting customer rates as a result of deferral account amortizations.

The rates contain information developing the level of the per therm change necessary to amortize the outstanding deferral balances of \$6,428,910 for the twelve months ended July 31, 2018. The \$6,428,910 is comprised of \$2,146,781 for the residential program, \$858,054 for the commercial program, \$254,796 for the low-income program, \$2,507,139 is for administration costs, and \$2,146,781 is for the residual balance from last year's filing. The total amortization requested in this filing is a debit of \$6,478,391. The annual revenue change reflected in this filing is an increase of \$3,267,281 to customers, or an increase in annual revenue of 1.40%. The slight increase is related to program targets in conservation. Below is a table summarizing the proposed changes reflected in this filing:

The impact of the CPA is a revenue increase of \$3,267,281 or a 1.40% increase. The impact to an average residential customer using 54 therms per month will be an increase of \$0.75.

The proposed change will affect all of Cascade's Washington customers. Cascade serves approximately 186,554 residential, 26,029 commercial and 466 industrial customers in the state of Washington.
